### Focus on Connecticut

In Connecticut, the school safety provisions in “An Act Concerning Gun Violence Prevention and Children’s Safety” outlines that each public school should adopt all-hazards safety standards. While schools are required to periodically update safety plans that provide for orientation to stakeholders, often administrators need assistance from security professionals well-versed in school safety protocols.
